## Disposal Fees

C&D	\$5.50 per cubic yard
XL C&D	\$8.50 per cubic yard
Mattress	\$25.00 per item (handling fee)
Re-Load Fee	\$50.00 per occurrence
Minimum Fee	\$25.00

## Permitted Waste Stream

Gentilly Landfill (P-0375) is permitted as a "Type III" solid waste facility by the Louisiana Department of Environmental Quality. This site is permitted to accept construction/demolition debris, woodwastes and yard trash, as defined by LAC 33:VII.115.

### Permitted Waste:

- Construction/Demolition Debris (C&D)
- Woodwaste
- Yard Trash
- Materials deemed acceptable by LDEQ Administrative/Emergency Orders
- Incidental admixture of C&D with asbestos-contaminated waste
- Other materials deemed acceptable by landfill management

### Prohibited Waste:

- Hazardous Waste
- Industrial Waste
- Commercial/Domestic Waste
- Household Hazardous Waste (HHW)
- Furniture
- Putrescibles (garbage, rotting food, etc.)
- White Goods (refrigerators, freezers, etc.)
- E-Waste (TVs, VCRs, Computers, etc.)
- Tires
- Asbestos Containing Materials (ACM)
- Friable Asbestos
- Liquid Waste
- Volatile Waste
- Flammable Waste
- Infectious Waste
- Treated Lumber
- Paint, oil, oil filters, motors, batteries, etc.
- Enclosed containers, gas cylinders, florescent light fixtures with ballast or neon
- Other material deemed NOT acceptable by landfill management

## Rules & Regulations

- Not responsible for accidents.
- Dump at your own risk.
- No trespassing on site. Customers must remain in designated areas.
- Speed limit is 10 MPH while on site.
- Consumption of alcoholic beverages or drugs of any kind is not allowed on site.
- No weapons, firearms or explosives allowed.
- No smoking at any time on site.
- No cameras or video equipment allowed.
- Children must remain in vehicle while on site.
- All customers are required to stay within 10 feet of their vehicle while on site.
- Customers are required to observe and obey all posted signs and site personnel at all times while on site.
- Trucks being unloaded by hand must be completely unloaded by closing time.
- Truck drivers must adhere to Gentilly Landfill spacing rules as directed by landfill management.
- At management discretion, certain loads may be rejected due to time needed to unload.
- No salvaging or scavenging allowed.
- All loads must be un-tarped before reaching the tower. Loads which are not un-tarped by the tower, will be directed out of line to do so.
- Pull-offs require a minimum of 15 feet between landfill equipment and customers' vehicles, no exceptions.
- Self-dumpers will be required to unload under their own power. Due to safety purposes, our dozers and loaders will not be allowed to assist in raising beds.
- Excavators will not be used for pull-offs or rake outs.
- Should customers need assistance with pulling, up-righting or anything involving landfill equipment, they will be required to sign a hold-harmless agreement.
- Pre-paid customers will be required to leave a check every Monday.
- All NSF checks will be assessed a \$25 fee. Customers with NSF checks unsettled for over 10 days, will be prosecuted.
- **LANDFILL MANAGEMENT RESERVES THE RIGHT TO REFUSE SERVICE TO ANYONE.**
